Ron Smith by RHR Smith gave a presentation regarding the 2020 annual audit. Mr. Smith strongly recommended a Tax stabilization fund in case the largest taxpayer does not pay.

Article 5 To Consider a Real Estate Abatement Request for Account #631.

A request for an abatement was submitted to the assessor for a demolition of a building on a property to reflect the 2020 Billing Tax bill. The owner would like \$23,800 building value removed. The assessor recommends to deny abatement due to assessment dates being set in statute as April 1st of each year. The building was demolished on 06/06/2020.

5:43 P.M. Laurie Gagnon motions to pro-rate the bill with the value to reflect June 6, for discussion. Manon Raymond seconds the motion for discussion.

Discussion was made that in the past the town would pro-rate. The boards change and it becomes inconsistent.

Jason Boucher, Laurie Gagnon and Manon Raymond all vote in favor of pro-rating the building. The owner will pay \$90.64 for building. Motion Passes.

Article 6 To Consider a Sewer Abatement Request for Account # 20785.

A request was made for a sewer abatement due to Hot water pipe burst in the late summer/early fall. A letter was received by the water district.

Endico lease has 30 acres agreement for a farmer to utilize and upkeep. The current tenant, David Ouellette of Lakeshore Farms would like to terminate agreement.

Two Farmers are interested in the endico site, Morin Farms of St David, and Pelletier Farms of Frenchville.
