Article 10 To Consider an Application For Abatement of Property Taxes for Personal Property Account 76.



Entry of incorrect values done on machinery and equipment; request is being made to abate the difference.

Article 11 To Consider an Emergency Medical Technician Memorandum of Understanding Between the U.S. Border Patrol, Houlton Sector and the Madawaska Ambulance Service.

US Border Patrol would like to enter into an agreement with the ambulance department if they can be permitted to ride along and assist with patients. This would be free service to the town.

- International Bridge Project The new bridge will be wide enough to support a recreational lane like snowmobiles/Atv's. There will be 3 lit flag posts at the International Boundary. Also, aesthetic lighting underneath the bridge.
- Sewer Project Problematic areas of sewer line located around St Thomas Street and Inn of Acadia is currently being worked on.
- Town/Chamber of Commerce Memorandum of Understand- a draft agreement to collaborate with goalsetting in the works. Questions were brought up why the Chamber did not do anything for small business day.
- Valley Recycling Facility- 1st draft of the 2021 VRF budget reviewed. They are looking into replacing a new crane.
