**TO:** Ross Dubois, a constable in the Town of Madawaska, County and State aforementioned.

**GREETINGS:**

**In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Madawaska, in said County, qualified by law to vote in said town affairs to meet at the Madawaska Middle/High School Library on Thursday February 15, 2018 at 6:30 pm to act on articles 1, 2, 3, 4, & 5.**

**Article 1** To choose a moderator to preside at said meeting.

**Article 2** To see if the voters of the Town will authorize the borrowing of \$6,105,000 plus interest not to exceed 2% for a period of 28 years from USDA Rural Development, for the purpose of waste water treatment facility and collection system upgrades and further authorize the Board of Selectmen, Town Manager, Treasurer and Clerk to sign any and all documents in connection with said borrowing."

**RECOMMENDED BY BOARD OF SELECTMEN AND FINANCE COMMITTEE**

**Article 3** To see if the voters of the Town will accept a Grant from USDA, Rural Development in the amount of \$1,895,000, said monies to be used for the purpose of waste water treatment facility and collection upgrades.

**RECOMMENDED BY BOARD OF SELECTMEN AND FINANCE COMMITTEE**

**Article 4** To see if the voters of the Town will authorize the Board of Selectmen to utilize an amount of money not to exceed \$250,000 from the undesignated fund balance for the purpose of funding the appraisal and legal costs of the Twin Rivers Paper Co. appraisal project, and for the cost of funding the new In-House Property Assessor position.

**Article 5**


To see if the voters of the Town will approve the acquisition of land commonly known as the Bicentennial Park, that is all of Lot 41 on Tax Map 6, from the Roman Catholic Bishop of Portland. In Lieu of Payment, the Acquisition Terms include snowplowing by the Town Madawaska Public Works of the St. Thomas Street Church and St David Church properties, and exemption of Sewer User Fees of those properties for a period of Thirty Years.




